#### VI. Marketing and Promotions

a. Rock-N-Stroll (Jody). Worked well in May. There are increasing vendors asking to participate. We may need to formulate a potential response to pop-up vendors.

In terms of Rock-N-Stroll the RDA will follow and implement the city of Oakland regulations on street and pop-up vendors. We will call code enforcement as needed should/when we encounter violations. (M) Monte, (S) Katy, Unanimous approval.

Chris will reach out to the city code enforcement guy for any tips and suggestions and report back to the board next month.

- b. Meeting outcomes with Rockridge Neighborhood Association (Stephanie). A group of board members met with the executive board of RCPC on Sunday, 5/15. The meeting was a good connection event, and generative of potential ways to partner and collaborate together on shared goals.

- b. Closed Businesses:
  - I Do Bridal (5332 College Avenue);
  - Hello Vintage is closing,
  - M10 Hair Salon is closing.
  - The lingerie store is emptying out the space.
  - Olivetos is officially closed
- c. Home Depot. It sounds like the possibility of Home Depot is increasing at the same time Steph reported that the land use for that space prohibits the sale of types of lumber, and plumbing materials. Following discussion we identified that taking a public stance against or for a potential business coming in to the district is a slippery slope. We'll revisit this topic as needed, recommending personal/individual stances over a board stance.

#### VIII. New Business

2022 Board Elections – in June. Jody is overseeing the timeline.

As of today we have received no e-nominations. Stephanie, Andrew, and Susan are all up for re-election, as their class expires. They thus have to be re-elected to serve another term.

Veronica recommended a clear protocol, process, of how to join the board.

We need to finish rounding up more potential nominees (3) by May 25<sup>th</sup>. Steph and Andrew will speak together about potential nominees. Jody will share the by-laws for folks to remember: 1 year commitment, hybrid monthly meeting. There is no fundraising work required.
